Should it be impossible to determine beneficial owner (for example because the ownership is too dispersed, no one owns or has control of the legal entity according to the Act on Beneficial Owners, or if the ownership is uncertain that individual, one or more, who in fact have control of the operation of the legal entity, should be considered as the beneficial owner and registered as such.
